RULES & REGULATIONS

Qualifying Rounds:

Contestant must be at least 18 years of age as of 1st January 2008.

- There will be 3 qualifying rounds on the following days:

Dates

- Saturday, 5 July 2008 at Northpoint
- Saturday, 12 July 2008 at Robertson Walk
- Saturday, 19 July at Compass Point

Each contestant must check in back stage one hour before the event for sign-in and to be assigned a number.

- Each contestant must wear Official Event T-shirt during contest.
- Anyone who attempts to hide a portion of a burger will be immediately disqualified.
- In event of a tie, the first tie-breaker will be the size of the uneaten portion left on the plate at the final horn. (The smallest left-over means the more of a burger consumed).
- Top five (5) finishers must make themselves available for post-event finals press conference.
- All contestants agree to have their photograph and name used in future Major League Eating promotions and advertising.
- There will be no more than 6 contestants per qualifying round.
- Contestants will compete against each other.
- Contestants may enter as many qualifying rounds as they desire. However, they can only take part in one of the rounds in the finals.
- Only the person who wins a qualifying round may compete in the finals. There will be no substitution.
- The top 5 winners from each food category will be eligible to take part in the finals. These 5 winners will be chosen based on the least amount of food left in the dish after the allotted time.

Each contestant will be scheduled for a specific time to compete and any contestant who is more than 30 (thirty) minutes late after the reporting time will be disqualified.

Each contestant, depending on their rounds, will have to eat as quickly the following food items within the specified time:

Round	Food Type	Quantity	Duration
1	Premium Otah	2kg	12min
2	Burgers	3kg	10min
3	Curry Puff	2kg	8min
4	Satay	4kg	12min

All food will be prepared by the respective sponsors at their designated kitchens and brought to the event venue in sealed aluminium containers.

- Any food in the contestant's mouth at the whistle counts toward the final tally if the competitor chews and swallows that portion.
- Contestants must not touch any food until the starting signal.
The contestant will be considered finished when the allotted is up.
If vomiting occurs anytime during the contest the contestants will be immediately disqualified.
The 6th and 7th finishers for each round will be placed in the standby list, in order of their least amount of food left.
In the event that any finalist(s) cannot attend the finals, the standby will be called to take their place.
- Judges will be on hand to assure adherence to contest rules and ensure fair play.

**Finals:**

The finals will be held on Sunday, 27th July 2008 at Robertson Walk from 4pm to 7pm.

Only the five (5) winners of each of the qualifying rounds are eligible to compete.

The person who consumes the most of their food type will be deemed the winner.

4. In the case of a tie, the contestant with the least amount of residue in the food tray will be judged the winner and the judges' decision is final.
5. If a contestant vomits anytime during the contest they will be disqualified.

Grounds for disqualification include:

- False or incomplete entry form or liability waiver.
- Health risks that could jeopardize the contestant's health or well being.
- Under the influence of any substance.
- Appearance that is deemed inappropriate.
- Starting prior to the start signal.
- Continuing to put food in the mouth after the ending signal.
- Throwing up or regurgitating.

Major League Eating Safety

Safety is the first consideration in any sport, and Major League Eating insists that all sanctioned competitive eating matches take place in a controlled environment with the proper safety measures in place. Major League Eating will not sanction or promote any events that do not adhere to the highest safety regulations.

Major League Eating believes that speed eating is only suitable for those 18 years of age or older and only in a controlled environment with appropriate rules and with a licensed emergency medical technician present. Major League Eating opposes at-home training of any kind, and strongly discourages younger individuals from eating for speed or quantity under any circumstances.
